CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Article 83(3))

STAMP ACT (AMENDMENT) ORDER, 2026

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement

1. This Order may be cited as the Stamp Act (Amendment) Order, 2026 and shall be deemed to have commenced on 1st January 2013.

Repeal of Part 9 of Chapter 34

2. Part 9 of the Stamp Act, in this Order referred to as the Act, is repealed.

Amendment of Schedule 1

3. Schedule 1 to the Act is amended —

(a) by deleting the items relating to Article 1 from the first and second columns;

(b) by deleting the items relating to Article 1A from the first and second columns.

Consequential amendments to other written laws

4. The provisions of the other written laws specified in the first column of the Schedule are amended in the manner set out in the second column thereof.
