CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and 5))

EMERGENCY (SUPPLEMENTARY SUPPLY) (1999) (NO. 5) ORDER, 2000

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated 27th. day of June, 1998 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

AND WHEREAS the sum of three thousand, five hundred and ninety six million, one hundred and eighty seven thousand, three hundred and eighty dollars (\$3,596,187,380.00) has been provided by the Emergency (Supply) (1999) Order, 1998;

AND WHEREAS the sum of three hundred and sixty five million, seven hundred and seventy seven thousand, six hundred and seventy dollars (\$365,777,670.00) has been provided by the Emergency (Supplementary Supply) (1999) (No. 1) Order, 1999;

AND WHEREAS the sum of twenty four million, five hundred and twelve thousand, eighty three dollars and forty one cents (\$24,512,083.41) has been provided by the Emergency (Supplementary Supply) (1999) (No. 2) Order, 1999;

AND WHEREAS the sum of one hundred and twenty seven million, eight hundred and eighty nine thousand, six hundred dollars and eighty three cents (\$127,889,600.83) has been provided by the Emergency (Supplementary Supply) (1999) (No. 3) Order, 1999;

AND WHEREAS the sum of eighty seven million, seven hundred and eighty thousand dollars (\$87,780,000.00) has been provided by the Emergency (Supplementary Supply) (1999) (No. 4) Order, 1999;

AND WHEREAS it is now requisite to make a further provision of nine million, six hundred and seventy three thousand, nine hundred and twenty one dollars and thirty seven cents (\$9,673,921.37);

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan has made the following Order —

- Citation. 1. This Order may be cited as the Emergency (Supplementary Supply) (1999) (No. 5) Order, 2000.
- Further Expenditure for the Year 1999. 2. (1) The issue of the sum not exceeding nine million, six hundred and seventy three thousand, nine hundred and twenty one dollars and thirty seven cents (\$9,673,921.37) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 1999, not provided or not fully provided for by the said Emergency (Supply) (1999) Order, 1998, the Emergency (Supplementary Supply) (1999) (No. 1) Order, 1999, the Emergency (Supplementary Supply) (1999) (No. 2) Order, 1999, the Emergency (Supplementary Supply) (1999) (No. 3) Order, 1999 and the Emergency (Supplementary Supply) (1999) (No. 4) Order, 1999 is hereby authorised.
- Appropriation. (2) The said sum is appropriated for the purposes specified in the Schedule.
- Replacement of amount advanced from Contingencies Fund. (3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule being the amount advanced from the Contingencies Fund created under subsection (1) of section 10 of the Constitution (Financial Procedure) Order, 1959, is hereby authorised.
