CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and (5))

EMERGENCY (SUPPLEMENTARY SUPPLY) (1996) (NO. 5) ORDER, 1997

WHEREAS His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 30th. day of July, 1996 has declared a state of emergency in the whole State ;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest ;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public services ;

AND WHEREAS the sum of three thousand, nine hundred and twenty four million, six hundred and sixty nine thousand and six hundred and forty dollars (\$3,924,669,640.00) has been provided by the Emergency (Supply) (1996) Order, 1995 ;

AND WHEREAS the sum of nine million, nine hundred and seventy three thousand, two hundred and seventy four dollars (\$9,973,274.00) has been provided by the Emergency (Supplementary Supply) (1996) (No. 1) Order, 1996 ;

AND WHEREAS the sum of ten million, eight hundred and fifty thousand, four hundred and seventy seven dollars (\$10,850,477.00) has been provided by the Emergency (Supplementary Supply) (1996) (No. 2) Order, 1996 ;

AND WHEREAS the sum of fifteen million, seven hundred and sixty nine thousand and twenty five dollars (\$15,769,025.00) has been provided by the Emergency (Supplementary Supply) (1996) (No.3) Order, 1996 ;

AND WHEREAS the sum of two hundred and eighty two million, one hundred and seventy five thousand and five hundred dollars (\$282,175,500.00) has been provided by the Emergency (Supplementary Supply) (1996) (No. 4) Order, 1996 ;

AND WHEREAS it is now requisite to make a further provision of twenty eight million, six hundred and sixty eight thousand, four hundred and eighty two dollars and forty seven cents (\$28,668,482.47) ;

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order :-

Short Title.	1. This Order may be cited as the Emergency (Supplementary Supply) (1996) (No. 5) Order, 1997.
Further Expenditure for the Year 1996.	2. (1) The issue of the sum not exceeding twenty eight million, six hundred and sixty eight thousand, four hundred and eighty two dollars and forty seven cents (\$28,668,482.47) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 1996, not provided or not fully provided for by the said Emergency (Supply) (1996) Order, 1995, the Emergency (Supplementary Supply) (1996) (No. 1) Order, 1996, the Emergency (Supplementary Supply) (1996) (No. 2) Order, 1996, the Emergency (Supplementary Supply) (1996) (No. 3) Order, 1996, and the Emergency (Supplementary Supply) (1996) (No. 4) Order, 1996 is hereby authorised.
Appropriation.	(2) The said sum is appropriated for the purposes specified in the Schedule.
Replacement of Amount Advanced from Contingencies Fund.	(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule being the amount advanced from the Contingencies Fund created under subsection (1) of section 10 of the Constitution (Financial Procedure) Order, 1959, is hereby authorised.
