CONSTITUTION OF BRUNEI DARUSSALAM

(Order under section 83(3) and (5))

EMERGENCY (SUPPLEMENTARY SUPPLY) (APPROPRIATION FROM DEVELOPMENT FUND) (NO. 1) ORDER, 1998

WHEREAS His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 30th day of July, 1996 has declared a state of emergency in the whole State ;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest ;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of emergency ;

AND WHEREAS the sum of six hundred and five million, one hundred and eighty six thousand, six hundred and eighty one dollars (\$605,186,681.00) has been provided by the Emergency (Appropriation From Development Fund) Order, 1997 ;

AND WHEREAS it is now requisite to make a further provision of three hundred and fifty two million, eighty nine thousand, three hundred and forty three dollars and twenty eight cents (\$352,089,343.28) ;

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty The Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order :-

1. This Order may be cited as the Emergency (Supplementary Supply) (Appropriation From Development Fund) (No. 1) Order, 1998.

Citation.

2. (1) The Appropriation of a further sum not exceeding three hundred and fifty two million, eighty nine thousand, three hundred and forty three dollars and twenty eight cents (\$352,089,343.28) from the Development Fund is hereby approved.
