CONSTITUTION OF BRUNEI DARUSSALAM**(Order under section 83(3) and (5))****EMERGENCY (SUPPLEMENTARY SUPPLY) (1998) (NO. 2) ORDER, 1998**

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 27th day of June, 1998 has declared a state of emergency in the whole State ;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest ;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service ;

AND WHEREAS the sum of three thousand, two hundred and sixty five million, nine hundred and seventy nine thousand and two hundred and thirty dollars (\$3,265,979,230.00) has been provided by the Emergency (Supply) (1998) Order, 1997 ;

AND WHEREAS the sum of one million, two hundred and ten thousand dollars (\$1,210,000.00) has been provided by the Emergency (Supplementary Supply) (1998) (No. 1) Order, 1998 ;

AND WHEREAS it is now requisite to make a further provision of eight million dollars (\$8,000,000.00) ;

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order :-

1. This Order may be cited as the Emergency (Supplementary Supply) (1998) (No. 2) Order, 1998. Citation.

2. (1) The issue of the sum not exceeding eight million dollars (\$8,000,000.00) from the Consolidated Fund is hereby authorised. Further
