CONSTITUTION OF BRUNEI DARUSSALAM
(Order under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2008/2009) (NO. 2) ORDER, 2009

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 4/08) dated the 15th. day of January, 2008 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam;

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand seven hundred and eighty-five million, seven hundred and eighty-five thousand, six hundred and forty-eight dollars (\$4,785,785,648.00) has been provided by the Supply (2008/2009) Act, 2008 (Act 1 of 2008);

AND WHEREAS the sum of thirty million dollars (\$30,000,000.00) has been provided by the Supplementary Supply (2008/2009) (No. 1) Order, 2008 (S 106/08);

AND WHEREAS it is now requisite to make a further provision of forty-three million, five hundred and twenty seven thousand, six hundred and thirty dollars (\$43,527,630.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by Articles 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2008/2009) (No. 2) Order, 2009.

Further expenditure for the year 2008/2009, appropriation and replacement of amount advanced from Contingencies Fund.

2. (1) The issue of a sum not exceeding forty-three million, five hundred and twenty seven thousand, six hundred and thirty dollars (\$43,527,630.00) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2008/2009, not provided or not fully provided for by the Supply (2008/2009) Act, 2008 (Act 1 of 2008) and the Supplementary Supply (2008/2009) (No.1) Order, 2008 (S 106/08) is hereby authorised.

(2) Such sum is appropriated for the purposes specified in the Schedule.

(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule bearing the amount advanced from the Contingencies Fund created by section 10(1) of the Constitution (Financial Procedure) Order is hereby authorised.
