SUCCESSION AND REGENCY PROCLAMATION, 1959

APPOINTMENT OF PERSONS APPOINTED UNDER SECTION 12(1)

WHEREAS by section 12(1) of the Succession and Regency Proclamation, 1959, it is provided that WE shall appoint persons for the purposes of section 12 of the Proclamation.

NOW THEREFORE WE, under and by virtue of the powers and authorities in that behalf conferred upon US by section 12(1) of the Succession and Regency Proclamation, 1959, do hereby appoint the following persons to be the persons appointed with effect from the day it is made —

- (c) Yang Berhormat Dato Seri Setia Awang Haji Erywan bin Pehin Datu Pekerma Jaya Haji Mohd. Yusof, Minister of Foreign Affairs II (Member of the Privy Council, Member of the Council of Ministers and Member of the Religious Council);
- (d) Yang Mulia Pengiran Dato Seri Paduka Haji Mohd Tashim bin Pengiran Haji Hassan, Deputy Minister of Religious Affairs (Member of the Council of Ministers and Vice-President of the Religious Council);

- (e) Yang Mulia Dato Paduka Awang Haji Hamiddon bin Haji Ibrahim, Private and Confidential Secretary to His Majesty the Sultan and Yang Di-Pertuan, His Majesty the Sultan and Yang Di-Pertuan's Office;
- (f) Yang Mulia Dato Paduka Haji Awang Rosli bin Pehin Orang Kaya Shahbandar Dato Seri Paduka Haji Mohd Salleh, Deputy Private and Confidential Secretary to His Majesty the Sultan and Yang Di-Pertuan, His Majesty the Sultan and Yang Di-Pertuan's Office;
- (g) Yang Mulia Pengiran Dato Paduka Haji Maun bin Pengiran Haji Said, His Majesty the Sultan and Yang Di-Pertuan's Office; and
- (h) Yang Mulia Dato Paduka Dr. Thirunavukkarasu Ganesan, Director of Non-Invasive Cardiology, Consultant Cardiologist and Physician, Gleneagles Jerudong Park Medical Centre.
