CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and (5))

EMERGENCY (SUPPLY) (2000) ORDER, 1999

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated 27th. day of June, 1998 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan has made the following Order —

1. This Order may be cited as the Emergency (Supply) (2000) Order, 1999, and shall come into force on the 1st. day of January, 2000.

2. (1) The issue of the sum not exceeding three thousand, two hundred and eighty one million, eight hundred and seventy thousand, four hundred and seventy four dollars (\$3,281,870,474.00) out of the Consolidated Fund for the service of the year 2000 is hereby authorised.

Issue and
Appropriation.

(2) The said sum is appropriated for the purposes specified in the Schedule.
