**OLD AGE AND DISABILITY PENSIONS
(PENSION OR ALLOWANCE) (AMENDMENT) RULES, 2021**

In exercise of the power conferred by section 23 of the Old Age and Disability Pensions Act, the Minister of Culture, Youth and Sports, with the approval of His Majesty the Sultan and Yang Di-Pertuan, hereby makes the following Rules —

Citation and commencement

1. These Rules may be cited as the Old Age and Disability Pensions (Pension or Allowance) (Amendment) Rules, 2021 and shall commence on the same date as the Old Age and Disability Pensions Act (Amendment) Order, 2021.

Amendment of rule 1 of R2 of Chapter 18

2. Rule 1 of the Old Age and Disability Pensions (Pension or Allowance) Rules, in these Rules referred to as the principal Rules, is amended by deleting “Old Age and Disability Pensions (Pension or Allowance) Rules” and by substituting “Old Age Pensions and Disability Allowances Rules” therefor.

Amendment of rule 2

3. Rule 2 of the principal Rules is amended by deleting the definition of “penghulu or ketua kampung” and by substituting the following new definition therefor —

“ “penghulu or village head” means the penghulu of a mukim or the head of a village respectively, approved and remunerated by the Government.”.

Amendment of rule 4

4. Rule 4 of the principal Rules is amended, in subrule (1), by deleting “for a pension”.

Amendment of rule 6

5. Rule 6 of the principal Rules is amended by deleting “comply with any directions which may be given by the Pensions Officer as to reporting” and by substituting “report to a Pensions Officer within 14 days of” therefor.

Amendment of rule 9

6. Rule 9 of the principal Rules is amended —

(a) in subrule (1), by deleting “ketua kampong” from the first line and by substituting “village head” therefor;

(b) in subrule (2), by deleting “ketua kampong” and by substituting “village head” therefor.
