## THE CONSTITUTION OF BRUNEI DARUSSALAM, 1959

THE EMERGENCY (STATUTORY FUNDS APPROPRIATION ENACTMENT,  
1959) (AMENDMENT) ORDER, 1984

(Order Under Section 83 (3))

In exercise of the powers conferred upon him by subsection (3) of Section 83 of the Constitution of Brunei Darussalam, 1959, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order :—

1. This Order may be cited as the Emergency (Statutory Funds Appropriation Enactment, 1959) (Amendment) Order, 1984. Short Title.
2. Section 2 of the Statutory Funds Appropriation Enactment, 1959 (hereinafter referred to as the Principal Enactment) is hereby amended by deleting the words and figures "Two hundred and fifty four million and ninety thousand dollars (\$254,090,000.00)" and substituting the following words and figures in their place, that is to say, "Four hundred and seven million and twenty thousand dollars (\$407,020,000.00)". Amendment of Section 2.
3. The Schedule to the Principal Enactment is hereby repealed and the following new Schedule is substituted therefor :— Amendment of Schedule.
