CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Articles 83(3) and (5))

SUPPLEMENTARY APPROPRIATION FROM DEVELOPMENT
FUND (2011/2012) ORDER, 2012

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 48/11) dated the 9th. day of August, 2011 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam;

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by any such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of \$1,050,000,000 (one thousand and fifty million dollars) has been approved by resolution of the Legislative Council on 14th. March, 2011 from the Development Fund for the year 2011/2012;

AND WHEREAS it is now requisite to approve and appropriate a further sum of ninety-five million, seven hundred and twenty-two thousand and five hundred and seventy-seven dollars (\$95,722,577) to meet the expenditure as mentioned in the Schedule hereunder;

NOW THEREFORE, in exercise of the powers conferred on him by Articles 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Appropriation from Development Fund (2011/2012) Order, 2012.

Issue and appropriation.

2. [1] The issue of a sum not exceeding ninety-five million, seven hundred and twenty-two thousand and five hundred and seventy-seven dollars (\$95,722,577) from the Development Fund is hereby authorised.

(2) Such sum is appropriated for the purposes specified in the Schedule.
