CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and 5))

EMERGENCY (SUPPLEMENTARY SUPPLY) (1998) (NO. 4) ORDER, 1999

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated 27th. day of June, 1998 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

AND WHEREAS the sum of three thousand, two hundred and sixty five million, nine hundred and seventy nine thousand, two hundred and thirty dollars (\$3,265,979,230.00) has been provided by the Emergency (Supply) (1998) Order, 1997;

AND WHEREAS the sum of one million, two hundred and ten thousand dollars (\$1,210,000.00) has been provided by the Emergency (Supplementary Supply) (1998) (No. 1) Order, 1998;

AND WHEREAS the sum of eight million dollars (\$8,000,000.00) has been provided by the Emergency (Supplementary Supply) (1998) (No. 2) Order, 1998;

AND WHEREAS the sum of thirty one million, seventy nine thousand, one hundred and ninety three dollars and eighty five cents (\$31,079,193.85) has been provided by the Emergency (Supplementary Supply) (1998) (No. 3) Order, 1999;

AND WHEREAS it is now requisite to make a further provision of one hundred and eighty four million, seven hundred and thirty four thousand, six hundred and eighty four dollars (\$184,734,684.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan has made the following Order —

Citation. 1. This Order may be cited as the Emergency (Supplementary Supply) (1998) (No. 4) Order, 1999.

Further Expenditure for the Year 1998. 2. (1) The issue of the sum not exceeding one hundred and eighty four million, seven hundred and thirty four thousand, six hundred and eighty four dollars only (\$184,734,684.00) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 1998, not provided or not fully provided for by the said Emergency (Supply) (1998) Order, 1997, the Emergency (Supplementary Supply) (1998) (No. 1) Order, 1998, the Emergency (Supplementary Supply) (1998) (No. 2) Order, 1998 and the Emergency (Supplementary Supply) (1998) (No. 3) Order, 1999 is hereby authorised.

Appropriation. (2) The said sum is appropriated for the purposes specified in the Schedule.
