CONSTITUTION OF BRUNEI DARUSSALAM

(Order made under Articles 83(3) and (5))

SUPPLEMENTARY SUPPLY (2011/2012) (NO. 7) ORDER, 2012

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 48/11) dated the 9th. day of August, 2011 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam;

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of five thousand one hundred and thirty million, seven hundred and eighty-five thousand and six hundred dollars (\$5,130,785,600.00) has been provided by the Supply (2011/2012) Act, 2011 (Act 1 of 2011);

AND WHEREAS the sum of nineteen million, five hundred thousand, nine hundred and twenty-eight dollars (\$19,500,928.00) has been provided by the Supplementary Supply (2011/2012) (No. 1) Order, 2011 (S 81/11);

AND WHEREAS the sum of twenty-eight million, one hundred and eighteen thousand, six hundred and fifty-nine dollars and seventy-six cents (\$28,118,659.76) has been provided by the Supplementary Supply (2011/2012) (No. 2) Order, 2012 (S 2/12);

AND WHEREAS the sum of four million, two hundred and ninety-one thousand, one hundred and two dollars and twenty-nine cents (\$4,291,102.29) has been provided by the Supplementary Supply (2011/2012) (No. 3) Order, 2012 (S 8/12);

AND WHEREAS the sum of forty-eight million, eight hundred and thirty-eight thousand, seven hundred and forty-three dollars (\$48,838,743.00) has been provided by the Supplementary Supply (2011/2012) (No. 4) Order, 2012 (S 9/12);

AND WHEREAS the sum of seven million, eight hundred and twenty-three thousand, six hundred and twelve dollars and forty-two cents (\$7,823,612.42) has been provided by the Supplementary Supply (2011/2012) (No. 5) Order, 2012;

AND WHEREAS the sum of ninety-four million, four hundred and seventy-eight thousand, four hundred and eighty-two dollars (\$94,478,482.00) has been provided by the Supplementary Supply (2011/2012) (No. 6) Order, 2012;

AND WHEREAS it is now requisite to make a further provision of fifteen million, nine hundred and ninety-four thousand, eight hundred and ten dollars and thirty-two cents (\$15,994,810.32);

NOW, THEREFORE, in the exercise of the powers conferred on him by Articles 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2011/2012) (No. 7) Order, 2012.

Further expenditure for the year 2011/2012, appropriation and replacement of amount advanced from Contingencies Fund.

2. (1) The issue of a sum not exceeding fifteen million, nine hundred and ninety-four thousand, eight hundred and ten dollars and thirty-two cents (\$15,994,810.32) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2011/2012, not provided or not fully provided for by the Supply (2011/2012) Act, 2011 (Act 1 of 2011), the Supplementary Supply (2011/2012) (No. 1) Order, 2011 (S 81/11), the Supplementary Supply (2011/2012) (No. 2) Order, 2012 (S 2/12), the Supplementary Supply (2011/2012) (No. 3) Order, 2012 (S 8/12), the Supplementary Supply (2011/2012) (No. 4) Order, 2012 (S 9/12), the Supplementary Supply (2011/2012) (No. 5) Order, 2012 and the Supplementary Supply (2011/2012) (No. 6) Order, 2012 is hereby authorised

(2) Such sum is appropriated for the purposes specified in the Schedule.

(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule bearing the amount advanced from the Contingencies Fund created by section 10(1) of the Constitution (Financial Procedure) Order is hereby authorised.
