CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Articles 83(3) and (5))

SUPPLEMENTARY SUPPLY (2010/2011) (NO. 4) ORDER, 2011

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 56/09) dated the 24th. day of November, 2009 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam;

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand, nine hundred and eighty-five million, seven hundred and eighty-five thousand and six hundred dollars (\$4,985,785,600.00) has been provided by the Supply (2010/2011) Act, 2010 (Act 1 of 2010);

AND WHEREAS the sum of sixteen million, three hundred and sixty-three thousand dollars (\$16,363,000.00) has been provided by the Supplementary Supply (2010/2011) (No. 1) Order, 2011 (S 4/11);

AND WHEREAS the sum of twenty-four million, three hundred and eighteen thousand, eight hundred and ninety-eight dollars and fourteen cents (\$24,318,898.14) has been provided by the Supplementary Supply (2010/2011) (No. 2) Order, 2011;

AND WHEREAS the sum of twelve million, seven hundred and twenty-six thousand, seven hundred and eighty-three dollars and forty-six cents (\$12,726,783.46) has been provided by the Supplementary Supply (2010/2011) (No. 3) Order, 2011;

AND WHEREAS it is now requisite to make a further provision of eighty-four million, two hundred and seventy-nine thousand, six hundred and twenty-four dollars and sixty-one cents (\$84,279,624.61);

NOW, THEREFORE, in the exercise of the powers conferred on him by Articles 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2010/2011) (No. 4) Order, 2011.

Further expenditure for the year 2010/2011 and appropriation.

2. (1) The issue of a sum not exceeding eighty-four million, two hundred and seventy-nine thousand, six hundred and twenty-four dollars and sixty-one cents (\$84,279,624.61) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2010/2011, not provided or not fully provided for by the Supply (2010/2011) Act, 2010 (Act 1 of 2010), Supplementary Supply (2010/2011) (No. 1) Order, 2011 (S 4/11), Supplementary Supply (2010/2011) (No. 2) Order, 2011 and Supplementary Supply (2010/2011) (No. 3) Order, 2011 is hereby authorised.

(2) Such sum is appropriated for the purposes specified in the Schedule.
