CHILDREN AND YOUNG PERSONS (AMENDMENT) ORDER, 2008

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement.

1. This Order may be cited as the Children and Young Persons (Amendment) Order, 2008 and shall commence on the same date as the Children and Young Persons Order, 2006 (S 9/06), in this Order referred to as the principal Order.

Amendment of section 2 of S 9/06.

2. Section 2 of the principal Order is amended, in subsection (1), in the definition of "place of safety", by deleting "100" from the second line and by substituting "97" therefor.

Amendment of section 104.

3. Section 104 of the principal Order is amended by inserting the following new paragraphs immediately after paragraph (b) —

(ba) in section 4, by inserting "and Juvenile Courts" immediately after "Magistrates" in the second line;

(bb) in section 5, by inserting "and Juvenile Courts" immediately after "Magistrates" in the first line;

(bc) in section 5A —

(i) by inserting "and Juvenile Courts" immediately after "Magistrates" in the first line;

(ii) in the proviso, by inserting "and a Juvenile Court" immediately after "Magistrate" in the first line;

(bd) in section 6, by inserting "and Juvenile Courts" immediately after "Magistrates" in the second line;

(be) in section 7 —

- (i) in subsection (1), by inserting "or any Juvenile Court" immediately after "Magistrate" in the first line;
- (ii) in subsection (2), by inserting "and a Juvenile Court" immediately after "Magistrate" in the first line;
- (iii) in subsection (3) —
 - (aa)* by inserting "or a Juvenile Court" immediately after "Magistrate" in the first line;
 - (ab)* by inserting "or a Juvenile Court" immediately after "Magistrate" in the twelfth line;
 - (ac)* in the proviso, by inserting "or a Juvenile Court" immediately after "Magistrates" in the second line;
- (iv) in subsection (4), by inserting "or a Juvenile Court" immediately after "Magistrate" in the third line;
- (v) in subsection (5), by inserting "or a Juvenile Court" immediately after "Magistrate" in the second line;

(bf) in section 8, by inserting "and a Juvenile Court" immediately after "Magistrate" in the second line;".
