**LAW REVISION ACT  
(CHAPTER 1)**

**LAW REVISION ORDER NO. 6 OF 2002**

In exercise of the powers conferred by subsections (1) and (2) of section 5 of the Law Revision Act, the Attorney General hereby makes the following Order —

**Citation and commencement.**

1. This Order may be cited as Law Revision Order No. 6 of 2002 and shall commence on the 30th. November, 2002.

**Substitution of pages.**

2. The removal from the Laws of the pages specified in the third column of Part A of the Schedule bearing on the face thereof or overleaf the legend specified in the fourth column thereof with reference to the written laws specified in the first and second columns thereof is hereby directed, and the inclusion in the Laws, in respective substitution of the pages so directed to be removed, of the pages specified in the third column of Part B of that Schedule bearing on the face thereof or overleaf the legend specified in the fourth column thereof with reference to those written laws is hereby authorised.
