CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Articles 83(3) and (5))

SUPPLEMENTARY SUPPLY (2009/2010) (NO. 4) ORDER, 2010

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 56/09) dated the 24th. day of November, 2009 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam;

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand, nine hundred and eighty-five million, seven hundred and eighty-five thousand and six hundred dollars (\$4,985,785,600.00) has been provided by the Supply (2009/2010) Act, 2009 (Act 1 of 2009);

AND WHEREAS the sum of thirty million dollars (\$30,000,000.00) has been provided by the Supplementary Supply (2009/2010) (No. 1) Order, 2009 (S 41/09);

AND WHEREAS the sum of twenty-three million, two hundred and eleven thousand, eight hundred and forty-six dollars (\$23,211,846.00) has been provided by the Supplementary Supply (2009/2010) (No. 2) Order, 2009 (S 53/09);

AND WHEREAS the sum of one hundred and fifty-four million, six hundred and ninety-two thousand dollars (\$154,692,000.00) has been provided by the Supplementary Supply (2009/2010) (No. 3) Order, 2010 (S 3/10);

AND WHEREAS it is now requisite to make a further provision of three hundred and forty million, two hundred and fifty-six thousand dollars (\$340,256,000.00);

NOW, THEREFORE, in exercise of the powers conferred on him by Articles 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2009/2010) (No.4) Order, 2010.

Further expenditure for the year 2009/2010 and appropriation.

2. (1) The issue of a sum not exceeding three hundred and forty million, two hundred and fifty-six thousand dollars (\$340,256,000.00) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2009/2010, not provided or not fully provided for by the Supply (2009/2010) Act, 2009 (Act 1 of 2009), the Supplementary Supply (2009/2010) (No. 1) Order, 2009 (S 41/09), the Supplementary Supply (2009/2010) (No. 2) Order, 2009 (S 53/09) and the Supplementary Supply (2009/2010) (No. 3) Order, 2010 (S 3/10) is hereby authorised.

(2) Such sum is appropriated for the purposes specified in the Schedule.
