CONSTITUTION OF BRUNEI DARUSSALAM
(Order under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2005/2006) (NO. 6) ORDER, 2006

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 22/04) dated the 8th. day of March, 2004 has declared and proclaimed as of that day a state of emergency in the whole State;

AND WHEREAS it is provided by Clause (3) of Article 83 of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Clause (5) of Article 83 of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand, four hundred and thirty-three million, eight hundred and fifty-two thousand, four hundred and six dollars (\$4,433,852,406.00) has been provided by the Supply (2005/2006) Order, 2005 (S 22/05);

AND WHEREAS the sum of thirty-one million, seven hundred and seven thousand, four hundred and ninety-nine dollars (\$31,707,499.00) has been provided by the Supplementary Supply (2005/2006)(No. 1) Order, 2005 (S 58/05);

AND WHEREAS the sum of twenty-eight million, nine hundred and thirty-four thousand, three hundred and fifty-one dollars and four cents (\$28,934,351.04) has been provided by the Supplementary Supply (2005/2006) (No. 2) Order, 2005 (S 62/05);

AND WHEREAS the sum of twenty-seven million dollars (\$27,000,000.00) has been provided by the Supplementary Supply (2005/2006)(No. 3) Order, 2005 (S 63/05);

AND WHEREAS the sum of twenty-nine million, three thousand and five hundred dollars (\$29,003,500.00) has been provided by the Supplementary Supply (2005/2006)(No. 4) Order, 2005 (S 73/05);

AND WHEREAS the sum of twenty-nine million, four hundred and eighty thousand, fifty-three dollars and six cents (\$29,480,053.06) has been provided by the Supplementary Supply (2005/2006)(No. 5) Order, 2005 (S 74/05);

AND WHEREAS it is now requisite to make a further provision of twenty-one million, one hundred and thirty-eight thousand, nine hundred and sixty-three dollars (\$21,138,963.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by Clauses (3) and (5) of Article 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2005/2006) (No. 6) Order, 2006.

Further expenditure for the year 2005/2006 and appropriation.

2. (1) The issue of the sum not exceeding twenty-one million, one hundred and thirty-eight thousand, nine hundred and sixty-three dollars (\$21,138,963.00) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2005/2006, not provided or not fully provided for by the Supply (2005/2006) Order, 2005 (S 22/05), the Supplementary Supply (2005/2006) (No. 1) Order, 2005 (S 58/05), the Supplementary Supply (2005/2006) (No. 2) Order, 2005 (S 62/05), the Supplementary Supply (2005/2006) (No. 3) Order, 2005 (S 63/05), the Supplementary Supply (2005/2006) (No. 4) Order, 2005 (S 73/05) and the Supplementary Supply (2005/2006) (No. 5) Order, 2005 (S 74/05) is hereby authorised.
