CONSTITUTION OF BRUNEI DARUSSALAM
(Order under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2003/2004) (NO. 4) ORDER, 2004

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency dated 8th. day of March, 2004 (S 22/04) has declared and proclaimed as of that day a state of emergency in the whole State;

AND WHEREAS it is provided by Clause (3) of Article 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Clause (5) of Article 83 of the Constitution of Brunei Darussalam that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand, four hundred and seven million, three hundred and ninety-one thousand, seven hundred and eighty-three dollars (\$4,407,391,783.00) has been provided by the Supply (2003) Order, 2002 (S 3/03);

AND WHEREAS the sum of thirty-two million, two hundred and forty thousand and eighty-eight dollars (\$32,240,088.00) has been provided by the Supplementary Supply (2003) (No. 1) Order, 2003 (S 49/03);

AND WHEREAS the sum of eight hundred and eighty-three million, eighty-three thousand, nine hundred and ninety-five dollars (\$883,083,995.00) has been provided by the Supplementary Supply (2003/2004) (No. 2) Order, 2003 (S 50/03);

AND WHEREAS the sum of forty-nine million, five hundred and thirty-five thousand, six hundred and ninety-five dollars and fifty-six cents (\$49,535,695.56) has been provided by the Supplementary Supply (2003/2004) (No. 3) Order, 2004 (S 41/04);

AND WHEREAS it is now requisite to make a further provision of one million, four hundred and eleven thousand, three hundred and fifty-five dollars (\$1,411,355.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by Clauses (3) and (5) of Article 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2003/2004) (No. 4) Order, 2004.

Further expenditure for the year 2003/2004, appropriation and replacement of amount advanced from Contingencies Fund.

2. (1) The issue of the sum not exceeding one million, four hundred and eleven thousand, three hundred and fifty-five dollars (\$1,411,355.00) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2003/2004, not provided or not fully provided for by the Supply (2003) Order, 2002 (S 3/03), the Supplementary Supply (2003) (No. 1) Order, 2003 (S 49/03) and the Supplementary Supply (2003/2004) (No. 2) Order, 2003 (S 50/03) and the Supplementary Supply (2003/2004) (No. 3) Order, 2004 (S 41/04) is hereby authorised.

(2) This sum is appropriated for the services specified in the Schedule.

(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule bearing the amount advanced from the Contingencies Fund created under subsection (1) of section 10 of the Constitution (Financial Procedure) Order is hereby authorised.
