CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and (5))

SUPPLEMENTARY SUPPLY (2001) (NO. 5) ORDER, 2003

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 22nd. day of April, 2002 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

AND WHEREAS the sum of four thousand, ninety two million, five hundred and sixteen thousand, one hundred and ninety dollars (\$4,092,516,190.00) has been provided by the Supply (2001) Order, 2000;

AND WHEREAS the sum of eight million, eight hundred and sixty four thousand, seven hundred and eighty two dollars and forty six cents (\$8,864,782.46) has been provided by the Supplementary Supply (2001) (No. 1) Order, 2001;

AND WHEREAS the sum of twenty two million, nine hundred and sixty eight thousand, nine hundred and twenty one dollars and fifty eight cents (\$22,968,921.58) has been provided by the Supplementary Supply (2001) (No. 2) Order, 2001;

AND WHEREAS the sum of one million, nine hundred and nine thousand, seven hundred and four dollars and twenty six cents (\$1,909,704.26) has been provided by the Supplementary Supply (2001) (No. 3) Order, 2002;

AND WHEREAS the sum of eight million, four hundred and fifty thousand dollars (\$8,450,000.00) has been provided by the Supplementary Supply (2001) (No. 4) Order, 2002;

AND WHEREAS it is now requisite to make a further provision of seven hundred, twenty-nine thousand and eight hundred eleven dollars (\$729,811.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2001) (No. 5) Order, 2003.

Further expenditure for the year 2001 and appropriation.

2. (1) The issue of the sum not exceeding seven hundred, twenty-nine thousand and eight hundred eleven dollars (\$729,811.00) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 2001, not provided or not fully provided for by the Supply (2001) Order, 2000, Supplementary Supply (2001) (No. 1) Order, 2001, Supplementary Supply (2001) (No. 2) Order, 2001, Supplementary Supply (2001) (No. 3) Order, 2002 and Supplementary Supply (2001) (No. 4) Order, 2002 is hereby authorised.

- (2) The said sum is appropriated for the purposes specified in the Schedule.
