CONSTITUTION OF BRUNEI DARUSSALAM
(Order made under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2015/2016) (NO. 2) ORDER, 2017

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency dated the 26th day of January 2017 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam.

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest.

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service.

AND WHEREAS it is provided by section 10(3) of the Constitution (Financial Procedure) Order that His Majesty the Sultan and Yang Di-Pertuan may, if he is satisfied that there has arisen an urgent and unforeseen need for expenditure for which no other provision exists and for which funds cannot be provided under section 13(4) of the Constitution (Financial Procedure) Order, make advances from the Contingencies Fund to meet that need.

AND WHEREAS the sum of five billion and seven hundred million dollars (\$5,700,000,000.00) has been provided by the Supply (2015/2016) Act, 2015 (Act 1 of 2015).

AND WHEREAS the sum of two hundred and two million, two hundred and forty thousand, five hundred and forty-nine dollars and thirty-seven cents (\$202,240,549.37) has been provided by the Supplementary Supply (2015/2016) (No. 1) Order, 2017.

AND WHEREAS it is now requisite to make a further provision of thirteen million, eight hundred and sixty-five thousand, two hundred and fifty dollars (\$13,865,250.00).

NOW, THEREFORE, in exercise of the powers conferred by Article 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation

1. This Order may be cited as the Supplementary Supply (2015/2016) (No. 2) Order, 2017.

Further expenditure for year 2015/2016, appropriation and replacement of sum advanced from Contingencies Fund

2. (1) The issue of a sum not exceeding thirteen million, eight hundred and sixty-five thousand, two hundred and fifty dollars (\$13,865,250.00) out of the Consolidated Fund for expenditure on the services specified in the second column of the Schedule for the year 2015/2016, not provided or not fully provided for by the Supply (2015/2016) Act, 2015 (Act 1 of 2015) and the Supplementary Supply (2015/2016) (No. 1) Order, 2017, is hereby authorised.

(2) For the purposes of subsection (1), the sum specified in the third column of the Schedule is appropriated to the head of expenditure specified in the first column thereto.

(3) The replacement of such sum with the sum specified in the fourth column of the Schedule, being the sum advanced from the Contingencies Fund, is hereby authorised.
