LEGISLATIVE COUNCIL AND COUNCIL OF MINISTERS
(REMUNERATION AND PRIVILEGES) ACT (AMENDMENT) ORDER, 2005

In exercise of the power conferred by Clause (3) of Article 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Legislative Council and Council of Ministers (Remuneration and Privileges) Act (Amendment) Order, 2005.

Amendment of section 2 of Chapter 134.

2. Section 2 of the Legislative Council and Council of Ministers (Remuneration and Privileges) Act, in this Order referred to as the Act, is amended —

(a) in subsection (1) —

- (i) by deleting the definition of "Member" and by substituting the following new definition therefor —

"Member" means a person appointed, nominated or elected, as the case may be, to the Legislative Council pursuant to or under the Constitution or a Member of the Council of Ministers, and includes the Speaker;;

- (ii) in the definition of "specified duty", by deleting "in Council" from the last two lines;

(b) in subsection (2) —

- (i) by deleting "doubts" from the first line and by substituting "doubt" therefor;
- (ii) by deleting "in Council" from the penultimate line and by substituting "the Sultan and Yang Di-Pertuan" therefor.

Substitution of section 3.

3. Section 3 of the Act is repealed and the following new section substituted therefor —

"Remuneration.

3. His Majesty the Sultan and Yang Di-Pertuan may by Order make provision for the remuneration of Members of the Legislative Council and of the Council of Ministers."

Amendment of section 4.

4. Section 4 of the Act is amended —

(a) by deleting "(1)" from the first line;

(b) by repealing subsection (2).

Amendment of section 5.

5. Section 5 of the Act is amended by deleting "provided by the Legislative Council and paid out of" from the second and last lines and by substituting "a charge on" therefor.

Amendment of section 6.

6. Section 6 of the Act is amended by deleting "in Council" from the first line and by substituting "the Sultan and Yang Di-Pertuan" therefor.

Amendment of Schedule.

7. The Schedule to the Act is amended —

(a) by deleting "Nominated and Elected" from the heading;

(b) in paragraph 4, by deleting the fullstop from the heading where it appears for the second time;

(c) in paragraph 6, by deleting "of \$150 per day or such amount per day as may from time to time be prescribed by Government Circular" from the second, third and fourth lines and by substituting "notified in the *Gazette*" therefor;

(d) in paragraph 10, by deleting "Controller" from the second line and by substituting "Director" therefor;

(e) by deleting paragraph 11, and by substituting the following new paragraph therefor —

"11. Subsistence allowance:

The Speaker, Ministers and Deputy Ministers will be entitled to subsistence allowances at the same rates and subject to the same conditions as an officer in Division I of the public service.

A Member, other than the Speaker, a Minister or a Deputy Minister, may be paid a subsistence allowance at the rate notified in the *Gazette*."

Amendment of Act.

8. The Act is amended by deleting "Assistant" from and by substituting "Deputy" therefor in the long title.
