CONSTITUTION OF BRUNEI DARUSSALAM
(Order under Article 83(3) and (5))

SUPPLEMENTARY SUPPLY (2004/2005) (NO. 5) ORDER, 2005

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 22/2004) dated the 8th. day of March, 2004 has declared and proclaimed as of that day a state of emergency in the whole State;

AND WHEREAS it is provided by Clause (3) of Article 83 of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by Clause (5) of Article 83 of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service;

AND WHEREAS the sum of four thousand, four hundred and twenty-one million, one hundred and eight thousand and fifty dollars (\$4,421,108,050.00) has been provided by the Supply (2004/2005) Order, 2004 (S 34/04);

AND WHEREAS the sum of thirty-nine million, five hundred and twenty-six thousand, one hundred and ninety-four dollars and fifty-eight cents (\$39,526,194.58) has been provided by the Supplementary Supply (2004/2005) (No. 1) Order, 2004 (S 68/04);

AND WHEREAS the sum of twenty-eight million, seven hundred and ninety-nine thousand, one hundred and eighty-eight dollars and five cents (\$28,799,188.05) has been provided by the Supplementary Supply (2004/2005) (No. 2) Order, 2004 (S 86/04);

AND WHEREAS the sum of nineteen million, five hundred and eighty-one thousand, two hundred and thirty-eight dollars (\$19,581,238.00) has been provided by the Supplementary Supply (2004/2005) (No. 3) Order, 2005 (S 21/05);

AND WHEREAS the sum of nineteen million, two hundred and thirty-eight thousand, nine hundred and sixty dollars and sixty-seven cents (\$19,238,960.67) has been provided by the Supplementary Supply (2004/2005) (No. 4) Order, 2005;

AND WHEREAS it is now requisite to make a further provision of eleven million, six hundred and two thousand, four hundred and fifty-seven dollars and ninety-one cents (\$11,602,457.91);

NOW, THEREFORE, in the exercise of the powers conferred on him by Clauses (3) and (5) of Article 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2004/2005) (No. 5) Order, 2005.

Further expenditure for the year 2004/2005, appropriation and replacement of amount advanced from Contingencies Fund.

2. (1) The issue of the sum not exceeding eleven million, six hundred and two thousand, four hundred and fifty-seven dollars and ninety-one cents (\$11,602,457.91) out of the Consolidated Fund for expenditure on the services specified in the Schedule for the year 2004/2005, not provided or not fully provided for the Supply (2004/2005) Order, 2004 (S 34/04), the Supplementary Supply (2004/2005) (No. 1) Order, 2004 (S 68/04), the Supplementary Supply (2004/2005) (No. 2) Order, 2004 (S 86/04), the Supplementary Supply (2004/2005) (No. 3) Order, 2005 (S 21/05) and the Supplementary Supply (2004/2005) (No. 4) Order, 2005 is hereby authorised.

(2) This sum is appropriated for the services specified in the Schedule.

(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule bearing the amount advanced from the Contingencies Fund created under subsection (1) of section 10 of the Constitution (Financial Procedure) Order is hereby authorised.
