CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and (5))

SUPPLEMENTARY SUPPLY (2003/2004) (NO. 2) ORDER, 2003

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 22nd. day of April, 2002 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

AND WHEREAS the sum of four thousand, four hundred and seven million, three hundred and ninety one thousand, seven hundred and eighty three dollars (\$4,407,391,783.00) has been provided by the Supply (2003) Order, 2002;

AND WHEREAS the sum of sixty three million, two hundred and forty thousand, and eighty eight dollars (\$63,240,088.00) has been provided by the Supply (2003) (No. 1) Order, 2003;

AND WHEREAS it is now requisite to make a further provision of eight hundred and eighty three million, eighty three thousand, nine hundred and ninety five dollars (\$883,083,995.00);

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2003/2004) (No. 2) Order, 2003.

Further expenditure for the year 2003/2004 and appropriation.

2. (1) The issue of the sum not exceeding eight hundred and eighty three million, eighty three thousand, nine hundred and ninety five dollars (\$883,083,995.00) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 2003, not provided or not fully provided for by the Supply (2003) Order, 2002, is hereby authorised.

(2) The said sum is appropriated for the purposes specified in the Schedule.
