**LEGAL PROFESSION (LAW SOCIETY OF BRUNEI DARUSSALAM)
(AMENDMENT) ORDER, 2003**

In exercise of the powers conferred by section 62 of the Legal Profession Act, His Majesty the Sultan and Yang Di-Pertuan in Council hereby makes the following Order —

Citation and deemed date of commencement.

1. This Order may be cited as the Legal Profession (Law Society of Brunei Darussalam) (Amendment) Order, 2003 and shall be deemed to have commenced on the same date as the Legal Profession Act (Amendment) Order, 2003 (S 40/03).

Amendment of paragraph 9 of S 42/03.

2. Paragraph 9 of the Legal Profession (Law Society of Brunei Darussalam) Order, 2003, in this Order referred to as the principal Order, is amended, in sub-paragraph (2), by inserting "or persons to whom a Residence Permit has been granted under regulations made under the Immigration Act (Chapter 17)" immediately after "nationals" in the last line.

Amendment of paragraph 15.

3. Paragraph 15 of the principal Order is amended —

(a) in sub-paragraph (b) of sub-paragraph (1), by deleting "7" from the second line and by substituting "5" therefor;

(b) in sub-paragraph (c) of sub-paragraph (1), by deleting "7" from the second line and by substituting "5" therefor;

(c) by repealing sub-paragraph (10).

Amendment of paragraph 16.

4. Paragraph 16 of the principal Order is amended —

(a) in sub-paragraph (b) of sub-paragraph (1), by deleting "7" from the second line and by substituting "5" therefor;

(b) in sub-paragraph (c) of sub-paragraph (1), by deleting "7" from the first line and by substituting "5" therefor.

Amendment of paragraph 17.

5. Paragraph 17 of the principal Order is amended, in sub-paragraph (2), by deleting "annual" from the first line.

Amendment of paragraph 20.

6. Paragraph 20 of the principal Order is amended —

(a) in sub-paragraph (1), by deleting "annual" from the first line;

(b) in sub-paragraph (2), by deleting "next following" from the last line and by substituting "in the following year" therefor.

Amendment of paragraph 22.

7. Paragraph 22 of the principal Order is amended, in sub-paragraph (a) of sub-paragraph (1), by deleting "annual" from the second line.
