CONSTITUTION OF BRUNEI DARUSSALAM

{Order made under Article 83(3) and (5)}

SUPPLEMENTARY SUPPLY (2013/2014) (NO. 2) ORDER, 2014

WHEREAS His Majesty the Sultan and Yang Di-Pertuan by a Proclamation of Emergency (S 58/2013) dated the 16th day of July 2013 has declared and proclaimed as of that day a state of emergency in the whole of Brunei Darussalam.

AND WHEREAS it is provided by Article 83(3) of the Constitution of Brunei Darussalam that when a Proclamation of Emergency has been made and so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan may make any Orders whatsoever which he considers desirable in the public interest.

AND WHEREAS it is provided by Article 83(5) of the Constitution of Brunei Darussalam that His Majesty the Sultan and Yang Di-Pertuan may, by such Order, make all such financial provisions as he thinks necessary during the period of the emergency, including provision for the public service.

AND WHEREAS the sum of five thousand four hundred and thirty million, seven hundred and eighty-five thousand dollars (\$5,430,785,000.00) has been provided by the Supply (2013/2014) Act, 2013 [Act 1 of 2013].

AND WHEREAS the sum of two hundred and fifty-five million, one hundred and forty-two thousand, two hundred and nine dollars (\$255,142,209.00) has been provided by the Supplementary Supply (2013/2014) (No. 1) Order, 2013 (S 82/2013).

AND WHEREAS it is now requisite to make a further provision of one hundred and ninety-five million, one hundred and twenty-two thousand, two hundred and thirty-one dollars and sixty-six cents (\$195,122,231.66).

NOW, THEREFORE, in the exercise of the powers conferred by Article 83(3) and (5) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2013/2014) (No. 2) Order, 2014.

Further expenditure for year 2013/2014 and appropriation.

2. (1) The issue of a sum not exceeding one hundred and ninety-five million, one hundred and twenty-two thousand, two hundred and thirty-one dollars and sixty-six cents (\$195,122,231.66) out of the Consolidated Fund for expenditure on the services specified in the second column of the Schedule for the year 2013/2014, not provided or not fully provided for by the Supply (2013/2014) Act, 2013 (Act 1 of 2013) and the Supplementary Supply (2013/2014) (No. 1) Order, 2013 (S 82/2013) is hereby authorised.

(2) For the purposes of subsection (1), the sum specified in the third column of the Schedule is appropriated to the head of expenditure specified in the first column thereto.
