CONSTITUTION OF BRUNEI DARUSSALAM
(Order under section 83(3) and (5))

SUPPLEMENTARY SUPPLY (2002) (NO. 2) ORDER, 2003

WHEREAS His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam by a Proclamation of Emergency dated the 22nd. day of April, 2002 has declared a state of emergency in the whole State;

AND WHEREAS it is provided by subsection (3) of section 83 of the Constitution of Brunei Darussalam, that when a Proclamation of Emergency has been made and for so long as such Proclamation is in force, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam may make any Orders whatsoever which he considers desirable in the public interest;

AND WHEREAS it is provided by subsection (5) of section 83 of the Constitution of Brunei Darussalam, that such powers shall include the power to make such financial provisions as may be necessary during the period of the emergency including provision for the public service;

AND WHEREAS the sum of four thousand, two hundred and fifty three million, seven hundred and eighty thousand, three hundred and seventy six dollars (\$4,253,780,376.00) has been provided by the Supply (2002) Order, 2001;

AND WHEREAS the sum of twelve million, one hundred and eighteen thousand, five hundred and eighty seven dollars and ten cents (\$12,118,587.10) has been provided by the Supplementary Supply (2002) (No. 1) Order, 2002;

AND WHEREAS it is now requisite to make a further provision of thirty eight million, six hundred and sixteen thousand, three hundred and sixty three dollars and eight cents (\$38,616,363.08);

NOW, THEREFORE, in the exercise of the powers conferred on him by subsections (3) and (5) of section 83 of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam has made the following Order —

Citation.

1. This Order may be cited as the Supplementary Supply (2002) (No. 2) Order, 2003.

Further expenditure for the year 2002, appropriation and replacement of amount advanced from Contingencies Fund.

2. (1) The issue of the sum not exceeding thirty eight million, six hundred and sixteen thousand, three hundred and sixty three dollars and eight cents (\$38,616,363.08) out of the Consolidated Fund for expenditure on the various services specified in the Schedule for the year 2002, not provided or not fully provided for by the Supply (2002) Order, 2001 and Supplementary Supply (2002) (No. 1) Order, 2002 is hereby authorised.

(2) The said sum is appropriated for the purposes specified in the Schedule.

(3) The replacement out of the amount shown in the third column of the amount shown in the fourth column of the Schedule being the amount advanced from the Contingencies Fund created under subsection (1) of section 10 of the Constitution (Financial Procedure) Order, 1959, is hereby authorised.
